

FIRST AMENDMENT TO THE
UNIVERSITY BANKING SERVICES AGREEMENT

This First Amendment to that certain University Banking Services Agreement, (the "First Amendment") is effective as of the 14th day of December, 2022 (the "First Amendment Effective Date") by and between The University of Cincinnati, organized and operated under Chapter 3361 of the Ohio Revised Code ("University"), and PNC Bank, National Association, a national banking association, with its principal office at 300 Fifth Avenue, Pittsburgh, Pennsylvania 15222 ("PNC Bank"). All capitalized terms used in this First Amendment and not defined shall have the same meaning given them in the Agreement.

WHEREAS, the parties entered into a University Banking Services Agreement dated April 1, 2018 (the "Agreement"); and

WHEREAS, the parties wish to remove certain ATMs from their Locations; and

WHEREAS, the parties agree that they will be bound by the terms hereof.

NOW, THEREFORE, in consideration of the covenants, promises and representations set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Section 6.d is deleted in its entirety and replaced with the following: d.) Grant PNC Bank ATM deployment privileges on campus of eight (8) ATM Locations, as listed in Schedule A. All ATMs shall be governed by and in accordance with the provisions of the Master License Agreement between PNC Bank and University entered into contemporaneously with this Agreement, which is attached hereto as Exhibit A and incorporated herein by this reference;
2. Section 6.e is deleted in its entirety
3. Schedule A to Exhibit A of the Agreement ("ATM Locations") is deleted in its entirety, and replaced with the revised Schedule A attached hereto.

Schedule B to Exhibit A of the Agreement ("ATM Locations") is deleted in its entirety, and replaced with the revised Schedule B attached hereto.

4. All provisions and terms and conditions of the Agreement not specifically addressed herein are hereby ratified and reconfirmed by the parties.

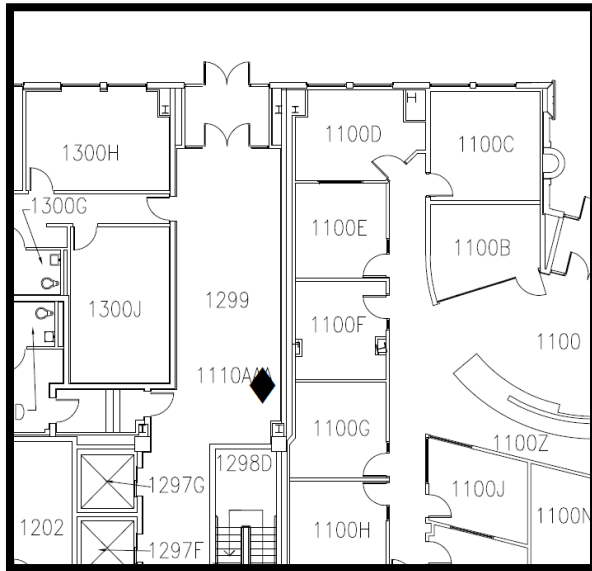

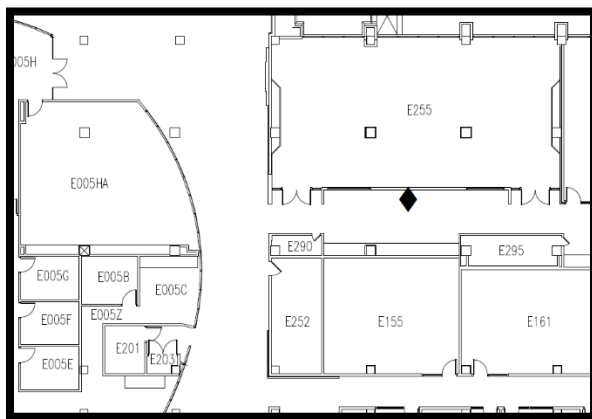
ATM LOCATIONS SCHEMATICS

Approximate ATM Locations are indicated by the diamond shapes “◆” in the schematics below.

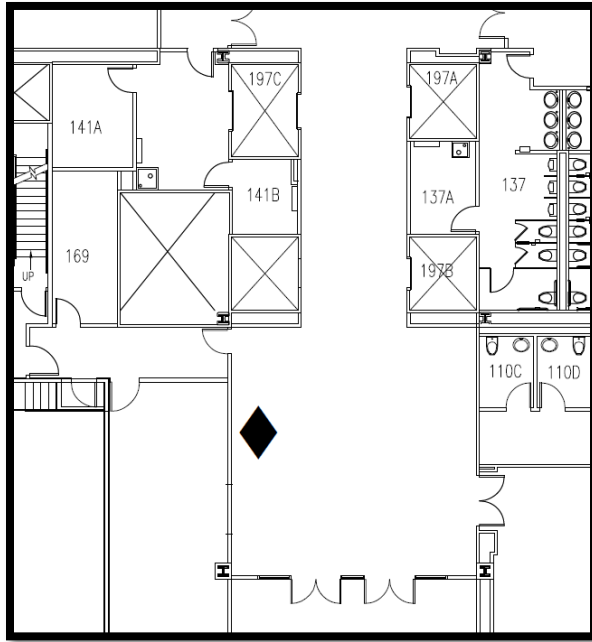
1. Edwards Center 45-51 Corry Boulevard 1299 a corridor.
across from 1300J



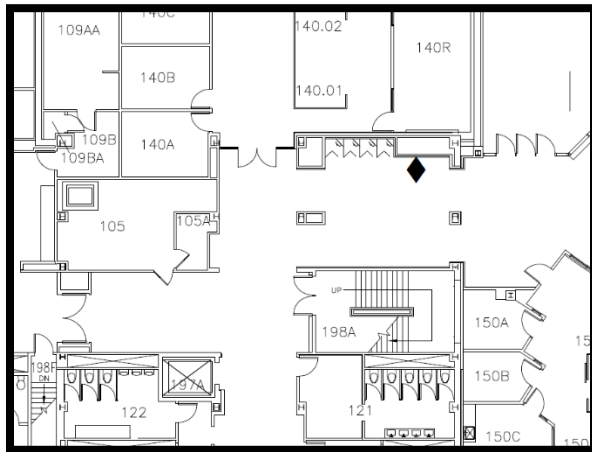
2. Medical Sciences Building 231 Albert Sabin Way E099
a corridor. adjacent to E001



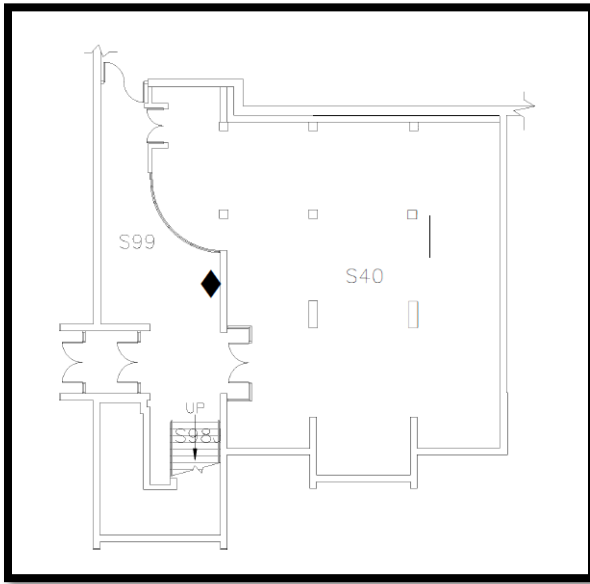
3. University Hall 51 Goodman Drive 199 a lobby,

north wall near 140 suite.



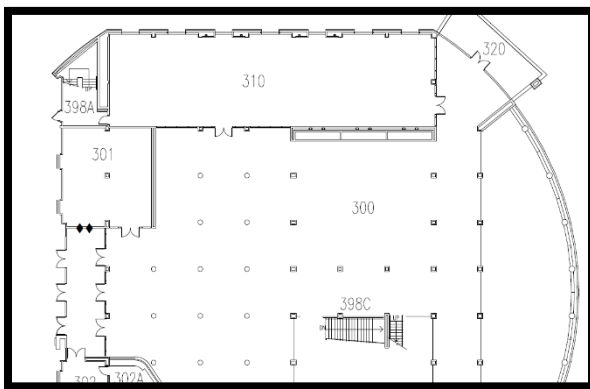
5. CC Snyder Addition 4200 Clermont College Drive S99 a
